# **"STATEMENT OF COMPLIANCE" PROGRAM AGREEMENT & INDEMNIFICATION**

## **Instructions for Program Submission**

1. Program producer **MUST** submit a signed Program Agreement and program should be delivered to the Programming Coordinator.
2. Program must meet or exceed technical requirements and be properly labeled.
3. Final decisions regarding specific cablecast times are made by CTV programming staff, as per CTV Rules & Procedures.
4. In the event that CTV receives a complaint which indicates that the program contract has been violated, producer agrees to postponing play-back until CTV can verify contract compliance.

## **Warranty Agreement**

I, the undersigned, warrant and represent to Citizens Television (CTV) that programs submitted by me contains none of the following:

1. any material that is libelous , slanderous, other defamation of character; or material that is an unlawful invasion of privacy;
2. any material that violates state or federal law relating to obscenity;
3. any material contrary to local, state, or federal laws;
4. any advertising or material that promotes any commercial product or service;
5. any solicitation or appeal for funds;
6. any unlawful use of copyrighted material.

I agree to apportion 20% of gross receipts of program sponsorships with Citizens Television, Inc.

CTV has the right of first use and reasonable reuse for the purpose of additional airing and promotion.

These warranties and representations are made by me in order that this program be cablecast free of charge on Citizens Television community access channel(s). I agree further, to indemnify and hold harmless Comcast Cable and CTV, their parent companies, subsidiaries, affiliates, directors, officers, employees, agents, representatives, successors and assigns, from any and all liability or damages (including reasonable attorney's fees) arising from or in connection with claims or causes of action for failure to comply with any applicable federal, state or local laws, rules or regulations or claims or causes of action for slander, libel, commercial disparagement or unfair trade practice, defamation of character, infringement of privacy or publicity rights, copyright, musical performing rights, unauthorized use of trademark, trade name or service mark or any other literary, dramatic or contractual right of any person, for breach of contractual or other obligations owing to third parties by any producer or program provider, or for any other injury or damage in law or equity, which claims result from said producers' or program providers' use of the access channel(s). I am aware that Section 639 of the Federal Cable Communications Policy Act of 1984 provides that:

"Whomever transmits over any cable system any matter which is obscene or otherwise unprotected by the Constitution of the United States shall be fined not more than \$10,000 or imprisoned not more than 2 years, or both."
